Notification for the members of the Central Securities Depository and Clearing House

The Decision on payment of interim dividend to the shareholders of Telecommunications Company Telekom Srbija a.d. Beograd ref. no. 419418/4-2013 was adopted at the 46th extraordinary session of the General Meeting held on 18 December 2013, whereby an approval was granted for the payment of interim dividend to the shareholders of Telecommunications Company Telekom Srbija a.d. Beograd, in cash, in the total gross amount of 7,571,846,498.00 dinars, i.e. gross amount of 9.4648 dinars per share.

All the shareholders of Telekom Srbija' a. d. Beograd – persons registered with the Central Securities Depository and Clearing House as the legal holders of shares of Telekom Srbija a.d. Beograd as at the shareholders' day, 8 December 2013 (Dividend Day) are entitled to the dividend.

For the purpose of calculating the tax on the revenues from capital on account of dividends received by the shareholders as non-resident taxpayers, which tax is paid as a withholding tax and applying the relevant tax rate stated in the agreements on avoiding double taxation, we would appreciate if you provide us with a certificate of residence for 2014 certified by the relevant authority of the country of residence for your non-resident clients who possessed any shares as at the Dividend Day – 8 December 2013 - and who are the residents of the countries with which the Republic of Serbia has concluded an agreement on avoiding double taxation. The certificate can be provided in the form prescribed by the tax authorities of the Republic of Serbia (POR-2) or as a translation issued in the form prescribed by the relevant authority of the country of residence with which an agreement on avoiding double taxation has been concluded and certified by sworn-in court interpreter. The certificates of residence for 2014 i.e. certified translations of foreign certificates of residence should be provided from January 3rd, 2014 until January 17th, 2014.

As for the shareholders - non-residents who fail to provide the certificate of residence or a certified translation in timely manner, Telekom Srbija a.d. Beograd shall calculate, withhold and pay the tax applying the tax rate envisaged under the applicable regulations of the Republic of Serbia.
